# CFU offers cost-sharing rebates to help customers pay for energy efficiency improvements.

How to qualify For heating, cooling, thermal envelope improvements or new construction, start by contacting CFU. For efficient appliances, recycling rebates, electric vehicles or our Plant a Tree program, review and complete application forms available online at cfu.net/rebates or at Cedar Falls Utilities, 1 Utility Parkway, Cedar Falls.

<b>②</b>	Water Heater - Gas Tankless	Up to \$300 (UEF > 0.95)
<b>②</b>	Water Heater - Heat Pump	Up to \$400 (UEF > 3.30)

CFU must provide water heating fuel source.

# THERMAL ENVELOPE IMPROVEMENTS

You must use a professional contractor and you must receive pre-approval from CFU for thermal envelope improvements (exceptions noted below). CFU will pay incentives on residential attic insulation provided that the existing insulation level is less than R-40. Rebate applications may be submitted for projects that increase the attic insulation up to a maximum of R-60. You can use any licensed contractor to qualify for CFU's air sealing and insulation incentives.

Window Air Conditioner	\$20

Limit 2 rebates per appliance type per year. Must serve facilities that receive CFU electric service. Must drop off at Cedar Falls Transfer Station or request City Refuse pick-up. Disposal fees will apply.

# **HEATING & COOLING EQUIPMENT**

To be eligible for a rebate, all heating & cooling improvements must be approved by CFU prior to installation.
