Available to premises located within CFU's service territory with access to the CFU broadband service. Determination of accessibility is at the sole discretion of CFU. The service delivered will be to one mobile computing device, provided by the District, per student. Internet access will be limited to this one device per student.

Rate: CFU will charge a rate of \$20 per month to the household. CFU will reduce that amount by the level of funding available from the District to a minimum of \$5 per month and CFU will bill the difference to the District.

For example, if the District has funding available to cover \$10 of the cost, CFU will bill the household \$10 and the District \$10, for a total of \$20. If the District has funding available to cover \$15 of the cost, CFU will bill the household \$5 and the District \$15.

The District and CFU shall evaluate the funding available to the District before each school year and adjust the proportion accordingly for each school year.
